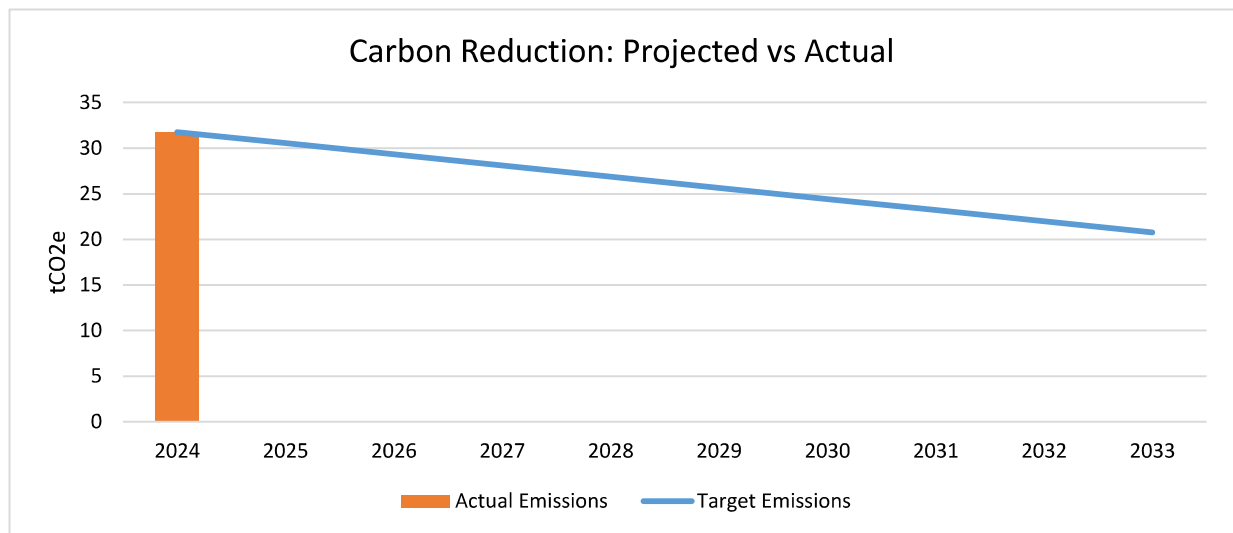

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 25.7 tCO<sub>2</sub>e by 2029. This is a reduction of 19.2 %

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2024 baseline and the measures will be in effect when performing the contract.

- Electric company cars
- Recycling of cardboard
- Purchase recycled water bottles and merchandise

### Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- Investigate changing to company electric vans when appropriate vehicles are available
- Switch to 100% renewable electricity
- Reduce single use plastics and water cups by having own water bottles
- Increase awareness of driver behaviour with a view to reducing fuel usage
- Find out whether our suppliers, Biobox & City Plumbing have Net Zero targets in place and what their plans is to decarbonise
